**4. Report of Scientific Officer**

a. News from the COST Office

Encouraged to put forward new ideas for future COST actions

b. Status of Action

Encouragement to use WEB page. Presented the value of Strategic Workshop such as that on Bioenergy that was held in Norway on 13<sup>th</sup> and 14<sup>th</sup> September 2006. Call will end on 31<sup>st</sup> March 2007. Appealing to action to make submissions before the very last minute. Can be submitted earlier and then changed subsequently so long as the title remains the same. Need to have 7 (better 10) countries with names of collaborators in each country. Don't have to coordinate with other proposed action. The next call will have funding for an increased number of COST actions.

Attending current meeting. Finland, Sweden, France, Germany, Austria, Switzerland, UK, Latvia, Poland

- d. Budget Status, budget allocation process  
Budget is good this year with €80,000.

**5. Year Budget planning**

Can be reimbursed for arrival the day before a meeting and departure the day after the meeting.

Steering Group Meeting in Florence in May 2006.

Planning meeting in Brussels in July 2006.

Working Group 3&4 meeting in Stockholm in August 2006.

Workshop in Warsaw in October 2006.

Will be WG1 meeting in Wageningen in December 2006.

Need to spend €45000 before end of April 2007 including STSM. Will then continue again in middle of September so cannot finance costs during summer.

**6. STSM status, applications**

John Barnett has 1 application currently. These are approved by Steering Committee. STSMs will need to be completed by end of May 2007 and report has to be submitted by middle of May. Can find information on COST action web site where there is a WEB tool for making the application. Reimbursement after report is received. Minimum 5 days and maximum 3 months. Maximum €2500. Has to be from a country in the action to another country in the action. Doesn't have to be a citizen of one of the countries in the action.

**7. Publications, annual report**

Good time to discuss a publication strategy.

Important to have progress report in place by 6<sup>th</sup> January 2007.

Request for copies of leaflet. Some mistakes need rectifying (update to management committee meeting, 3 members from Germany and end date should be 2009 and not 2008). John Barnett will also produce a new poster.

Need to have extended abstracts of presentations within 2 weeks (Monday 6<sup>th</sup> November). Jarik Oktaba will provide a template by beginning of next week.

Discussion on the possibility of producing a book on a particular topic. Not good for individual scientists profile but books can have long-term impact. No agreement on whether to take this forward at the moment.

**8. Evaluations**

Monitoring is carried out through progress report. Not sure if there will be a mid-term evaluation but there will be a final evaluation. Information in the Secretariat Note provided at the meeting about the evaluation process.

**9. Request for new member countries**

If there are groups that it would be useful to have within the action they should be asked to approach their National COST coordinator. Italy, Spain, Portugal, Ireland and Norway should be approached and then inform the chair of the action (John Barnett)

A list of non-Cost countries qualifying for support was provided in the Secretariat Note. Monies have been set aside specifically to support researchers from Albania, Bosnia and Herzegovina, Russian Federation and Ukraine.

**12. Progress report of working groups**

WG1: Workshop in December. Will be discussing cellulose and nanotechnology and possibilities for collaborative research. In collaboration with Tuula Teeri. Investigating possibilities of using nanotechnology to mimic how cellulose is constructed.

WG2: Planning some new ventures in Europe about fundamental work on lignin biosynthesis. Will have a meeting to discuss the very latest understanding in this field and to discuss potential funding for a new research programme in this area. Probably will have meeting on 15<sup>th</sup> February 2007 with around 6 people.

WG3: Workshop in Stockholm in August which had 2 guest speakers

WG4: Joint workshop with WG3 on Modelling: Models available, data available, validation, model species. 19/20<sup>th</sup> April 2007.

**13. Long-term planning**

Next workshop is in Potsdam. Will be in 2<sup>nd</sup> half of year, probably end of September (provisionally 26<sup>th</sup>-28<sup>th</sup> September with alternative 17<sup>th</sup>-19<sup>th</sup> October). Planning meeting will be in Potsdam on 22<sup>nd</sup> January 2007. Working title is "Structure and Function of the Primary and Secondary Cell Wall". Need to have rigorous advertisement of the conference.

WG 2/3/4 Meeting in Montpellier on 15<sup>th</sup>/16<sup>th</sup> March 2007 on "Mechano-Reception and Reaction Wood Formation"

Date and time of a larger meeting in Spring 2008. Provisionally 2-4<sup>th</sup> April 08.
