

## Governance Theme

Our governance research focuses on the relationship between institutions, decision-making processes, and sustainable management of trees woods and forests in the wider landscape.

A major focus is the relationship between science, policy and practice, and the ways in which evidence is generated, understood and used by different stakeholders in planning and land management.

Our current research focuses on the scope for trees and woodlands within national and local planning frameworks; the value of partnerships that deliver forestry strategy objectives; the range of community woodland models and their relevance to sustainable development and empowerment; influences on decisions about wildlife management; and the engagement of private landowners in woodland creation and management.
