INTRODUCTION

A visitor survey was carried out at two sites in the Llanymddyfri Forest District in 2000, Talybont, and Mynydd Du.

Talybont – Blaen-y-Glyn

Blaen-y-Glyn is located in the Black Mountains and within reasonable distance from Abergavenny. The Blaen-y-Glyn area consists of two car parks, the upper site, the survey site, consists of a picnic area and waymarked forest walk, which connects the top car park to the bottom car park. The area is situated on the site of an old reservoir village, the remains of which can be seen along the forest walk, which also passes several waterfalls. Ancient stone walls and a labyrinth of permissive paths, which run throughout the Brecon Beacons National Park, bound the surrounding area. A stream runs along side the top car park (which has spaces for 50 cars) past the picnic area, making it an attractive and popular location. The Black Mountains are heavily used by walkers and outward bound organisations for a number of varied activities, and historically the area is of considerable interest.

The objectives of conducting the survey were to gain basic visitor number figures enabling statistical analysis, and provide a basis on which expenditure can be balanced.

Mynydd Du – North Grwyne Fawr

Mynydd Du is located a short distance from Crickhowell which is situated on the A40 between Brecon and Abergavenny. Mynydd Du consists of two car parks, the furthest one, North Grwyne Fawr (the survey site), has parking for over 50 vehicles, whilst South Grwyne Fawr is much smaller and has become somewhat run down. North Grwyne Fawr offers good picnic facilities, with tables situated next to the river Grwyne Fawr, and although the site provides no waymarked walks, there is a public right of way to Grwyne Fawr reservoir offering splendid views, and permissive access to Forestry Commission land that surround the site. The area also offers a wealth of historical interest and has been the subject of many books.

The site is popular to walkers, picnickers and campers, the latter having become a serious problem. The objective of the survey, as with Blaen-y-Glyn, is to provide information on visitor numbers, justify expenditure, but more importantly to capture the public's and community's views on the illegal camping issue. It is hoped that by providing such information on the camping issue that the necessary steps can be taken to eliminate the problem.

SUMMARY

This report provides results from a visitor survey that took place at Llanymddyfri Forest District. A total of 270 questionnaires were completed, 121 at Mynydd Du and 149 at Talybont.

41% of the groups consisted of 2 people, with a further 16% of groups consisting of 4 people. 91% of groups included adults aged between 25-59 years, 17% included senior citizens, 11% included young adults aged 16-24 years, and 33% of groups included children. 16% of all groups had dogs with them, and 2% of groups had bicycles with them.

Almost half of the respondents had travelled from home that day. Of those who did not travel from home, the most popular choice of accommodation was camping and caravanning.

Almost one third of respondents had travelled between 6 and 15 miles to get to the woodland, 23% travelling between 16 and 25 miles with a further 23% travelling between 26 and 50 miles.

94% respondents had travelled by car or van to get to the woodland.

55% of respondents had visited the sites before. Of those who had visited the woodland before, 44% visit at least 1 - 3 times a year, with a further 42% less often.

40% had found out about the woodland through a local guide book/map, a further 25% had always known.

60% of respondents were visiting the sites to walk (with or without dogs).

41% of groups were staying for around 4 hours plus.

12% of respondents had used the waymarked walks in Talybont. Of those who had used the walks, 87% thought the route marking and 31% thought the quality of the path was poor, or very poor.

89% of respondents thought it was a good idea to develop a campsite in Mynydd Du.

Almost all the respondents used the car park. 81% of respondents used the road signs. 78% of respondents had used the picnic area. 66% of respondents used the information boards.

The facilities were generally rated OK or good by those who had used them. *The road signs and especially the information boards tended to be rated lower than other facilities.*

66% of respondents rated the management of the woodland as good or very good.

LLANYMDDYFRI VISITOR SURVEY 2000

The Llanymddyfri Visitor Survey ran between August and September 2000. A total of 370 interviews were carried out, 121 at Mynydd Du and 149 at Talybont.

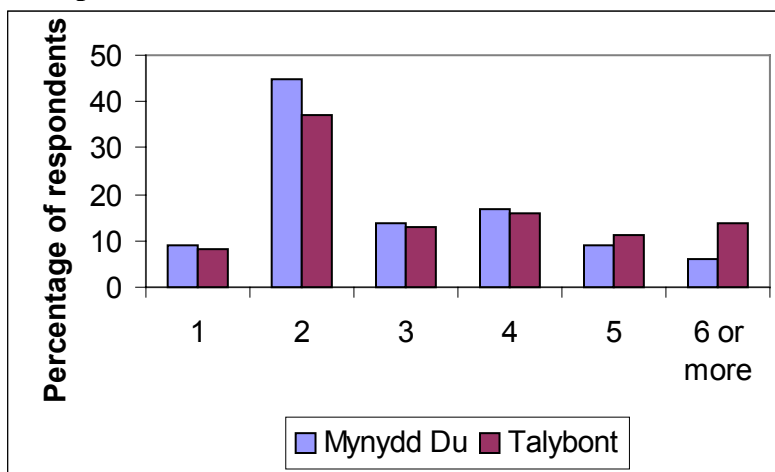
Group Composition

There were a total of 930 visitors in the 270 groups interviewed. There was an equal split of male and female visitors (52% of all visitors were male).

41% of groups included 2 people, and 14% consisted of 3 people. 16% of groups consisted of 4 people.

Excluding groups of 10 or more, there were on average 3 people per group.

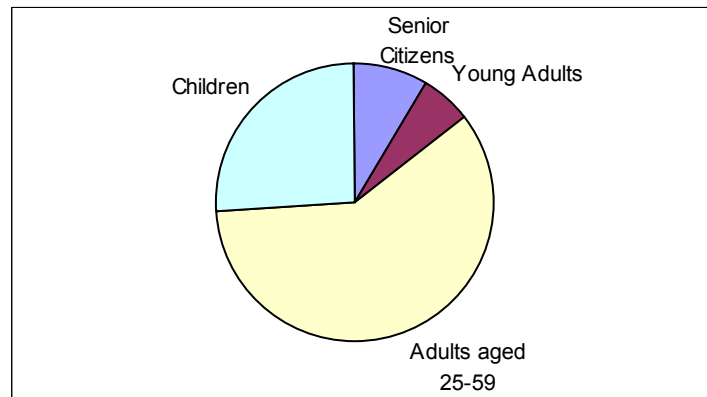
Figure 1.1: Group Size



The majority of groups (91%) included adults aged between 25-59 years, and 17% included at least one senior citizen. 11% of groups included young adults and 33% included children.

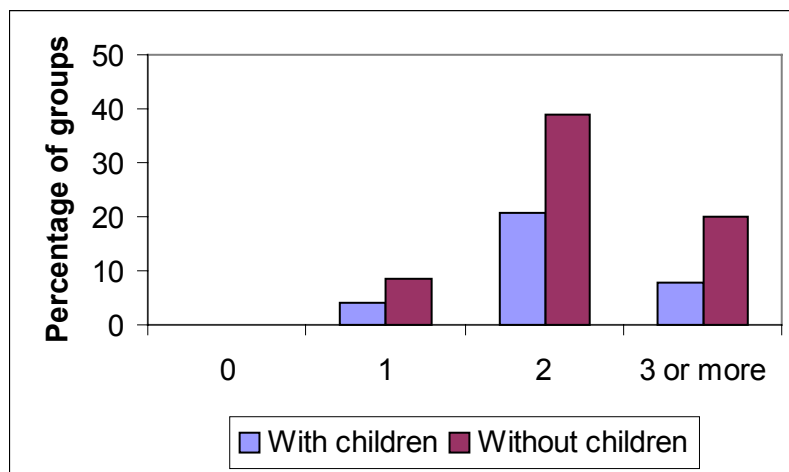
In terms of total visitors, adults aged between 25-59 years accounted for 59% of all visitors. 26% of all visitors were children, and 9% were senior citizens.

39% of groups included two adults and no children, and a further 20% included three or more adults. 21% of groups consisted of two adults with children, and 8% consisted of 3 or more adults with children.

Figure 1.3: Type of Group

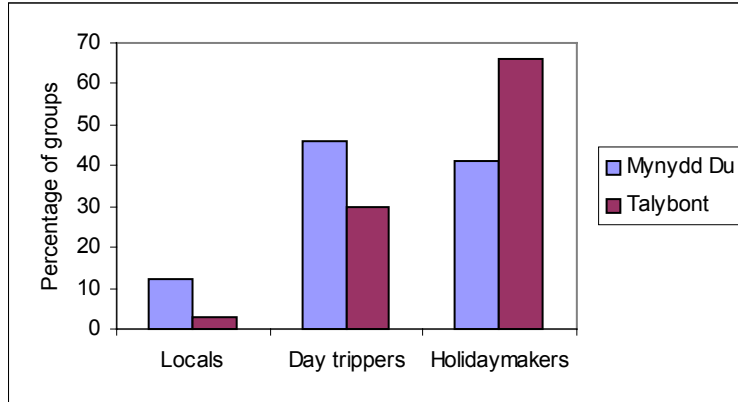


Around 16% of all groups had dogs with them. 2% of all groups were on/ with a bike.

Type of Visitor

The majority of visitors (66%) to Talybont were holidaymakers. The majority of visitors (46%) to Mynydd Du were Day trippers. Very few visitors (7%) to the woodland in the Llanymddyfri Forest District lived locally.

Visitor Profile

All of those interviewed were asked to provide their full home postcode.

Each of these postcodes was assigned an “ACORN” code. The Acorn classification was created using cluster analysis of the 1991 Population Census to divide almost all postcodes in 54 “types”. These types can be aggregated into 17 “groups” and the groups into 6 broad “categories” (A to F). Addresses in postcodes within any “type” will therefore tend to have a lot in common and can be given a label which describes the typical member of that “type”, e.g. “Wealthy suburbs, large detached houses”.

The acorn codes are reassigned each year to represent demographic changes since 1991.

The table below shows the proportion of valid postcodes from the survey that fall into each group. This is then compared to the overall GB population using an index, to look for similarities and differences between the two.

The table indicates that the level of visits to Llanymddyfri is generally highest among “Affluent Greys, Rural Communities” (A2) and “Affluent Executives, Family Areas” (B4).

Visitor Origin

All those interviewed were asked to provide their full postcode. Table 1.3 shows the origin of visitors, based on the home postcodes and town/ country names supplied.

45% of respondents visited the woodlands from Wales and the West Midlands.

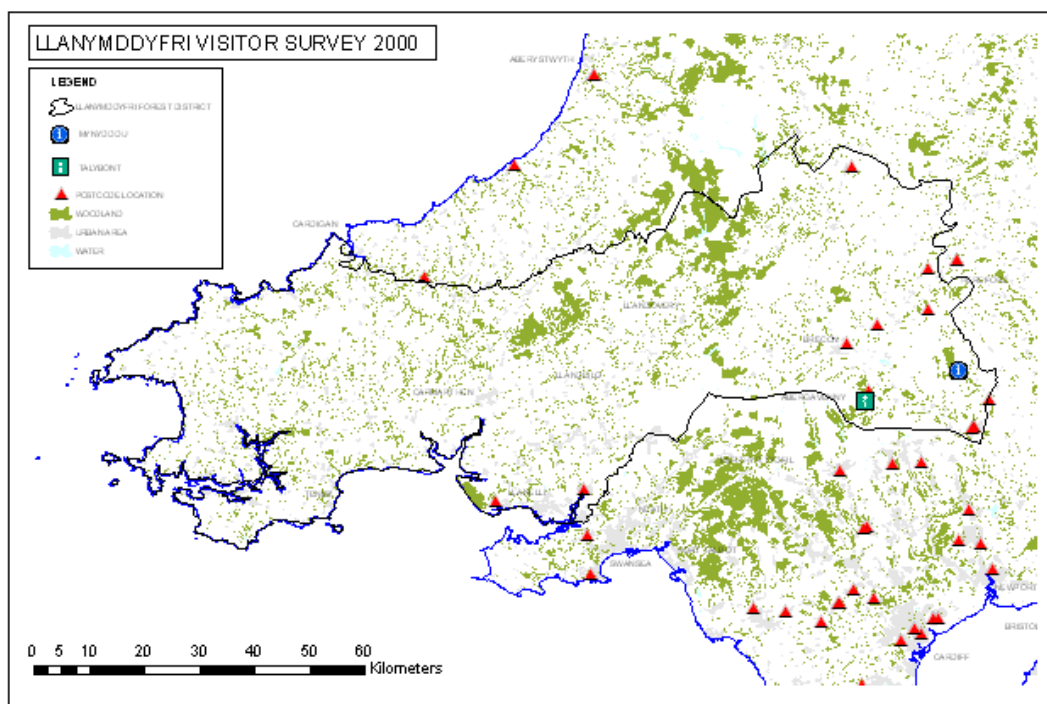


Figure 1: Map indicating the origin of visitors to the Llanymddyfri Forest District sites from the local area

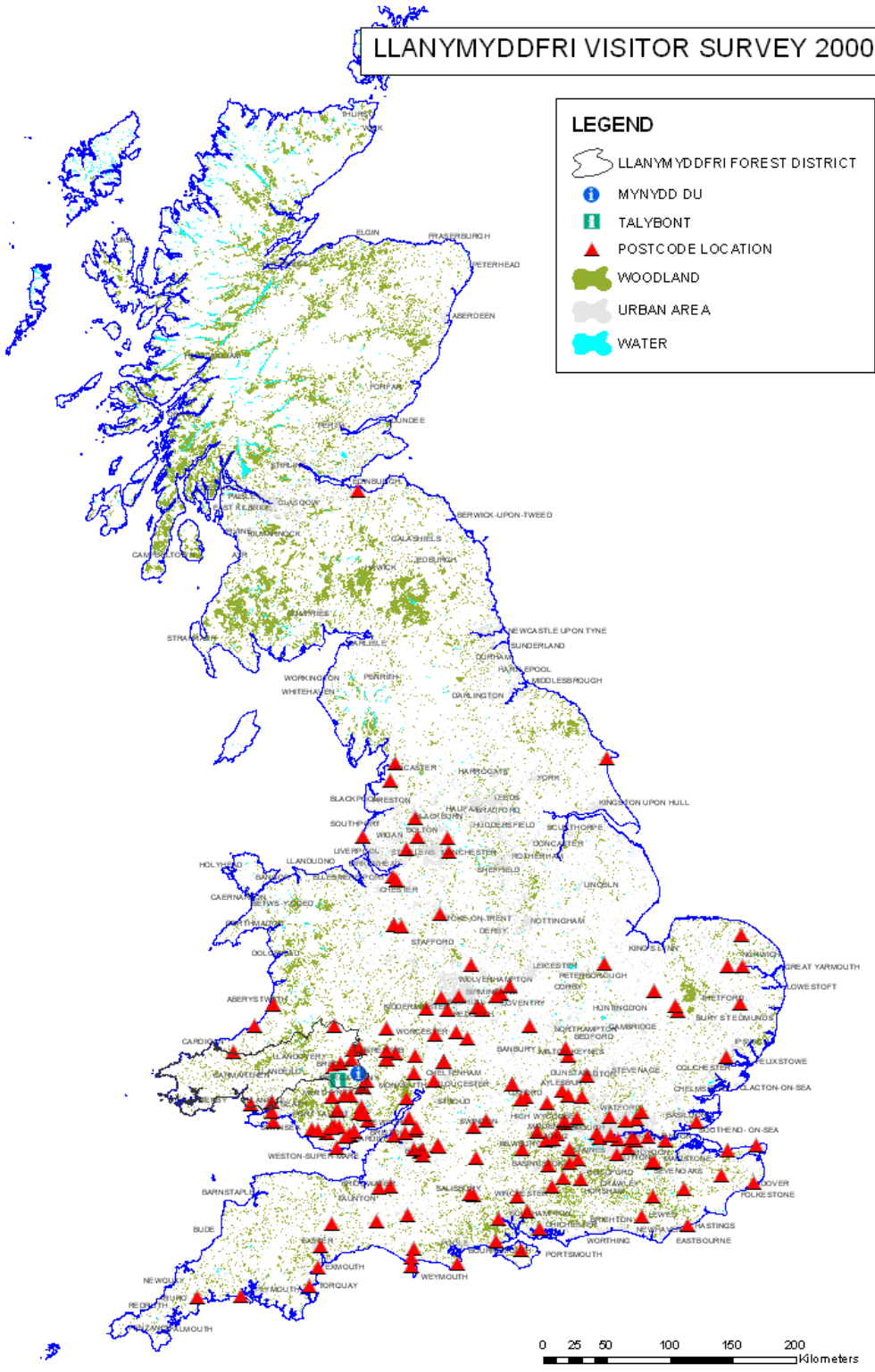
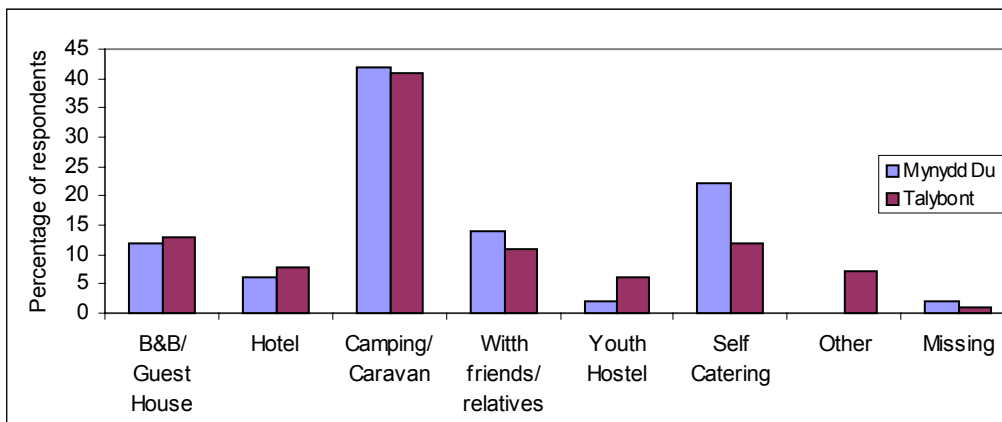


Figure 2: Map indicating the origin of visitors giving a valid postcode, to the Llanymyddfri sites from the whole of GB

Type of Trip

45% of respondents had travelled from home that day. 42% of holidaymakers were camping/caravanning, and 15% were staying in self-catering accommodation .

Almost one third of respondents had travelled between 6 and 15 miles to reach the site. 23% had travelled between 16 and 25 miles and a further 23% travelled between 26 and 50 miles .

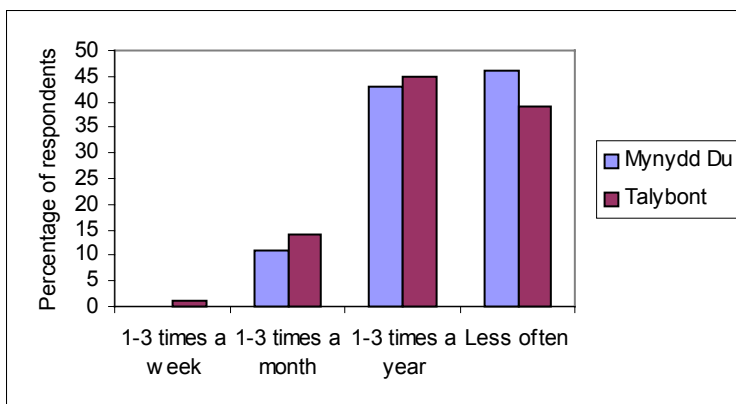
Type of Transport

94% of respondents had travelled by car or van to get to the woodland.

Previous Visits

55% of visitors had been to the woodland before. Of those who had visited the site before, 44% visit between 1 and 3 times a year

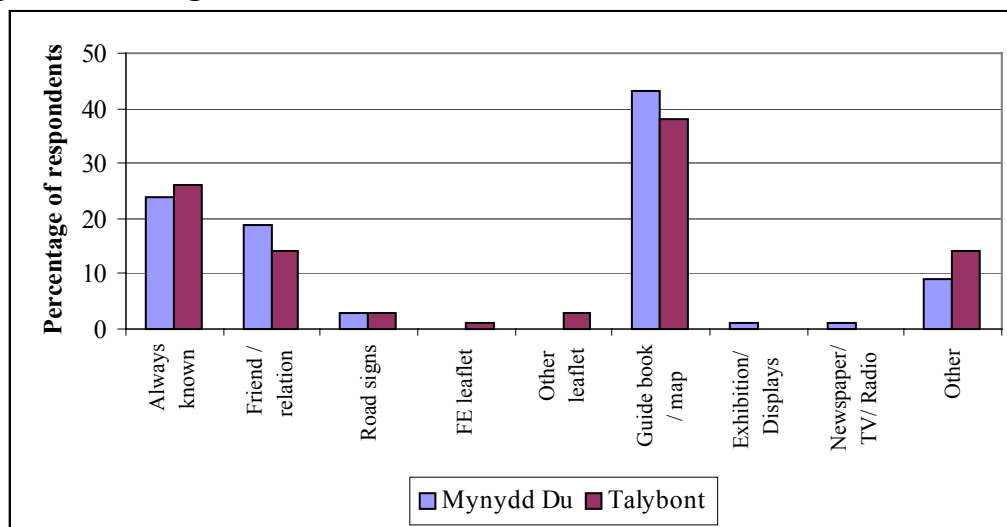
Figure 3: Frequency of Visits



Finding out about the site

40% of all respondents had discovered the site through a local guidebook or map. Around one quarter of respondents had always known about the site, with a further 16% finding out through friends or relations.

The table below shows that the majority of repeat visitors had always known about the site, or had found out through friends or relatives. 29% of first time visitors had found out about the site through friends or relatives, with a further quarter through local guidebooks or maps.

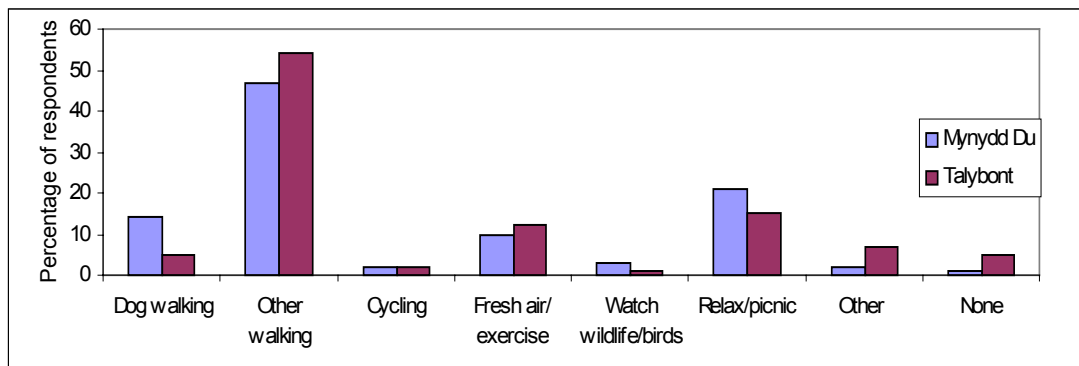

Main purpose of visit

60% of respondents at the woodland were visiting the sites to walk (including dog walking). A further 17% of all visitors interviewed had come to the sites to relax/picnic.

Figure 5: Main purpose of Visit

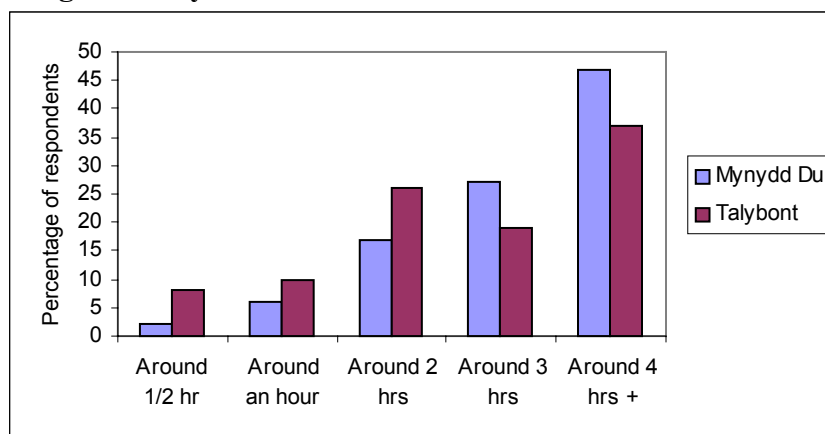


Length of Stay

41% of respondents were staying at the woodland for around 4+ hours. 23% were staying for around 3 hours and 21% were staying around 2 hours.

The average length of stay at Mynydd Du was 3.7 hours and the average length of stay at Talybont was 3.0 hours.

Waymarked Walks at Talybont

12% of respondents had used the waymarked walks. Of those who used the path, 87% thought that the route marking was poor or very poor. 28% thought that the quality of the path was poor or very poor.

Campsite in Mynydd Du

89% of respondents thought it was a good idea to develop a campsite in Mynydd Du.

Ratings of facilities

The results below present the ratings for each facility in terms of the proportion of visitors who expressed an opinion (i.e. the proportion who had used each facility and provided a rating for it).

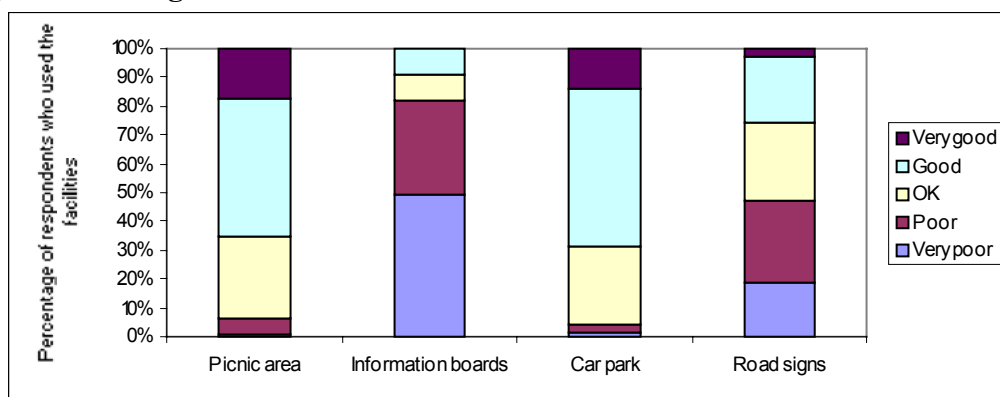
78% of respondents had used the picnic area. Of these, 64% rated it as good or very good.

66% of respondents used the information boards. Of those who had used the information boards, 83% rated it poor or very poor.

96% of respondents used the car park. Of those 68% rated them as good or very good.

81% of respondents used the road signs. Of these, 25% rated them as good or very good.

Management of the Woodland

60% of respondents who expressed an opinion rated the management of the forest as good or very good.

Possible Improvements

The most popular suggestion was to improve the toilets around the sites. Other suggestions were litter bins, more picnic tables, better road signs and better information boards. 10% of the respondents thought nothing at Mynydd Du or Talybont needed improving.

Special Needs

4% of respondents had special needs. Of these 71% had mobility needs, and a further 21% had sight needs.

CONCLUSION

In response to observations made whilst the 2000 surveys were being undertaken, improvements have been made to both areas.

These improvements have been in the form of the introduction of historical interpretation boards to both sites in Talybont as well as North Grwyne Fawr at Mynydd Du. Further improvements to signage throughout both areas have been made, with new threshold signs and road signs. New picnic benches have been installed at Talybont, as have new waymarkers on the waterfalls walk. Additionally better trailhead signs have been installed in response to only 12% of visitors using the walk.
