

## Authorised Agents – Northern England

The below list of agents have signed a contract with the Forestry Commission authorising them to provide services to land owners/managers issued with a Statutory Plant Health Notice (SPHN) to control the spread of *Phytophthora ramorum*. This list is valid for Financial Year 2012/2013 and only for SPHNs served in England.

The Forestry Commission will pay the agent for providing certain levels of service to help land owners/managers comply with the terms of a SPHN. The amount the Forestry Commission will pay depends on the level of service provided, as set out in the contract.

Agents wishing to be included on the list should complete a Pre-Qualification Questionnaire; a copy can be found on the Forestry Commission website or requested from the FC England Plant Health Team ([plant\\_health\\_england@forestry.gsi.gov.uk](mailto:plant_health_england@forestry.gsi.gov.uk)). Please note that contracts are issued per individual agent, not per company.
