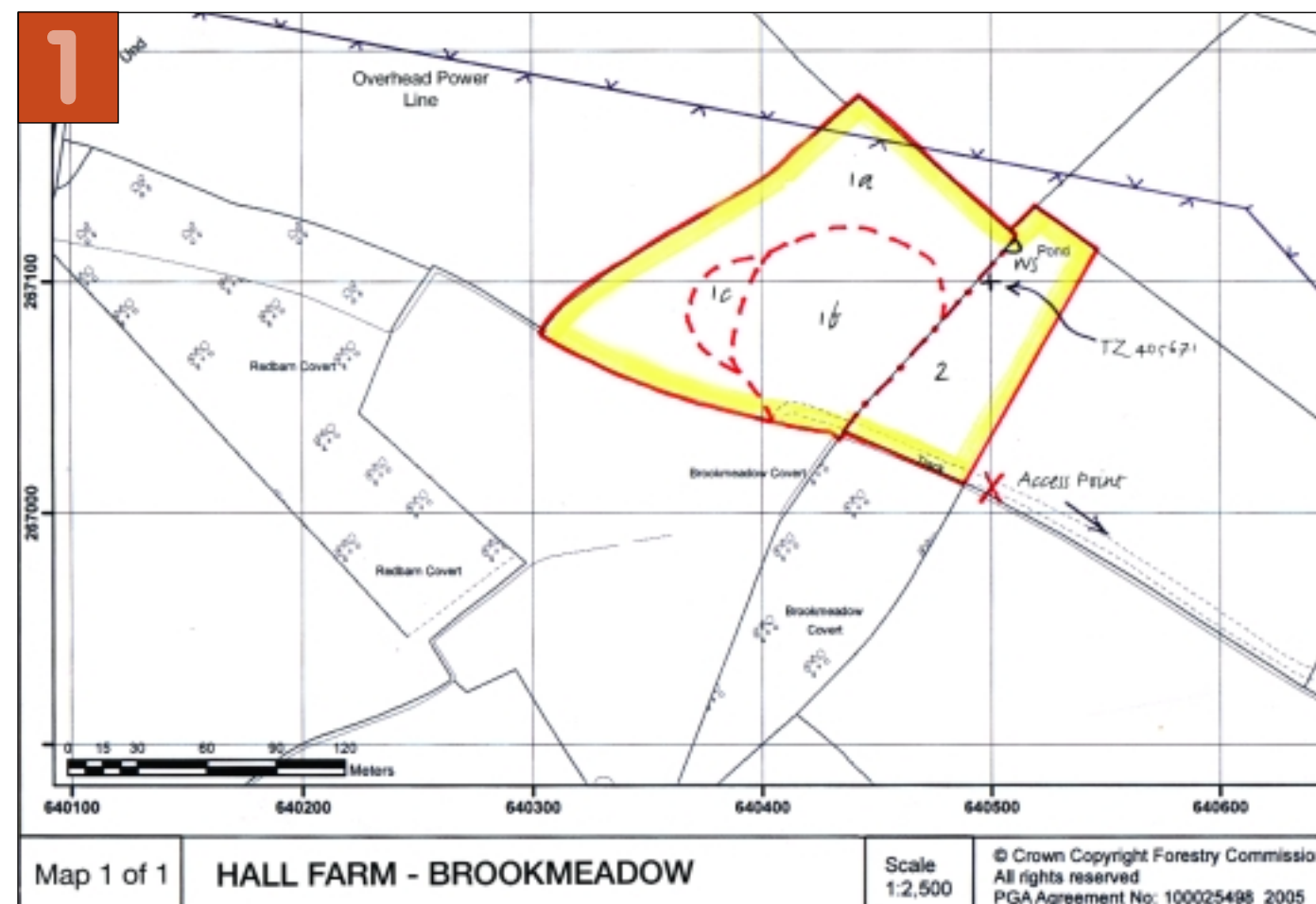

## Example of a Woodland Creation Grant Application

- 1 First the map is marked up to show the subcompartments and boundaries of areas where grant is being applied for, and any planned differences in the planting specification and woodland use.
- 2 Form EWGS 1 then records these subcompartments or compartments along with some brief information about them.
- 3 Form EWGS 7 then records the details of the planting, the use of the woodland and the grants applied for. Where several areas have the same details, these have been grouped together into a Work Group to reduce repetition. Standard Proposals have been referenced, and adjusted as required, by the Work Group text in column 16.
